Moonwalk Safety Rules

1. An adult attendant who has read and understands all the safety and installation rules must be on duty at all times.
2. No one over the age of 14 is allowed in the moonwalk. This is for children only.
3. No shoes allowed while in the moonwalk.
4. Empty pockets and remove eyeglasses, jewelry and any hard or sharp objects before jumping in the moonwalk
5. Group children according to age and size before entering the moonwalk.
6. It's recommended that no more than 4-5 children should be in the moonwalk at once.
7. No climbing or hanging on mesh walls.
8. Don't bounce near the doorway.
9. Do not inflate the moonwalk in high wind.
10. If the wind exceeds 20 mph while being used, unload the occupants and deflate the moonwalk.
11. Unit must be staked down and tied to concrete blocks prior to and during operation.
12. Do not allow children in the moonwalk when it is raining or when the moonwalk is wet.

Moonwalk Installation Instructions

1. Find a dry, level surface away from overhead power lines.
2. Keep a 5-foot unobstructed area around the moonwalk
3. Tarp should be placed on the ground first. This helps prevent damage to the bed of the ride.
4. Unroll the moonwalk on the tarp. Locate the inflation tube on the back side of the moonwalk.
5. Make sure that access to the door of the moonwalk is clear at all times.
6. Ride should be staked before using. Before staking, check to see that you won't be hitting any underground utilities.
7. The blower fan must be installed on a dry flat surface using the extension cord provided.
8. Check the inflation tube to make sure it is tightened around the blower. **Don't place hand or fingers into fan discharge or inlet opening when the fan is running.**
9. Make sure the deflation tube is also properly closed so that the moonwalk will inflate properly
10. Don't inflate the moonwalk in a high wind.
11. When properly inflated, the play area, walls, and columns will be firm.
12. Don't operate in the rain. Place motor in a dry area.
13. When deflating moonwalk, turn off blower and detach inflation tube. Then open deflation tube and let the air escape.
14. After all of the air has escaped, you can fold up the moonwalk.
 - a. Fold the moonwalk in half from front to back
 - b. Fold in half again—front to back
 - c. Roll up moonwalk and tuck in inflation tubes. Roll up moonwalk very tightly and try to get out any excess air.
15. **Do not try to lift moonwalk without help.** It is very heavy and could cause injury.
